

## **MRS/AQR Recruiter Accreditation Scheme**

## **Application for RAS Accredited Company**

There are two types of company accreditation:

- RAS Accreditation (In-House): For organisations which undertake in-house recruitment only, RAS Accreditation (In-house) will be given once 50% or more of the organisations' staff undertaking recruitment have successfully achieved accreditation.
- RAS Accreditation (External): For those organisations that use the services of external freelance recruiters, RAS Accreditation (External) will be given once 50% or more of all inhouse staff undertaking recruitment are RAS Accredited Recruiters and at least 50% of all external recruiters (such as independent recruiters) that are used by the organisation are RAS Accredited Recruiters

For MRS to verify a company's eligibility for RAS Accredited Company status please complete the application for either RAS Accreditation (In-House) or RAS Accreditation (External), as appropriate.
