


Setting up a web account:

As a Company Partner employee you are eligible to access a variety of online resources and personal development tools. The first step towards receiving these benefits is to set up a web account, if you already have a web account you can **skip to section 2.**

- Please visit www.mrs.org.uk
- Click on MyMRS in the top right-hand corner and click 'Create account' which will take you to the registration page. Fill in the form and submit to create your new account.
- Please ensure you indicate you are a Company Partner by ticking the box and selecting the right Company Partner name from the drop down menu. This will enable you to access the Company Partner area of the website and all the resources and benefits in it.

- Update your personal information

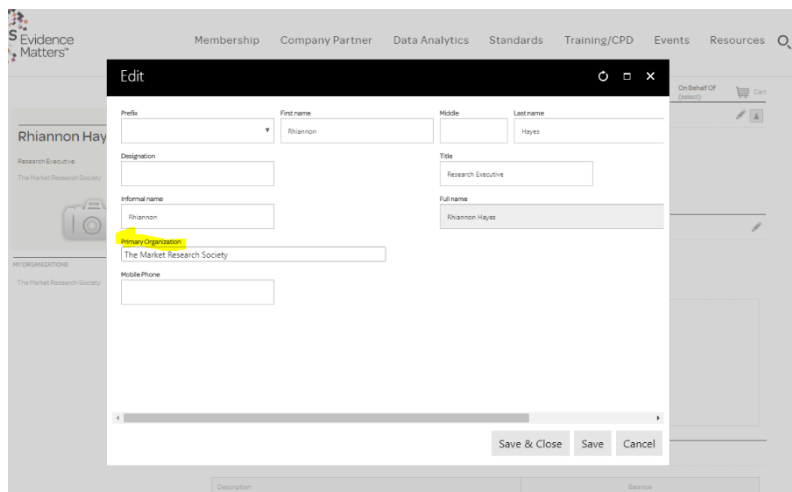
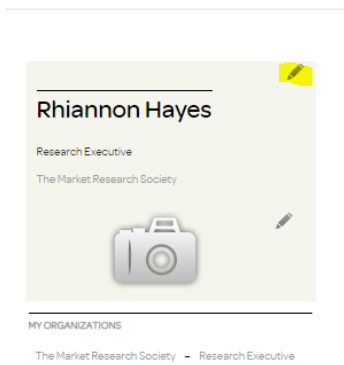
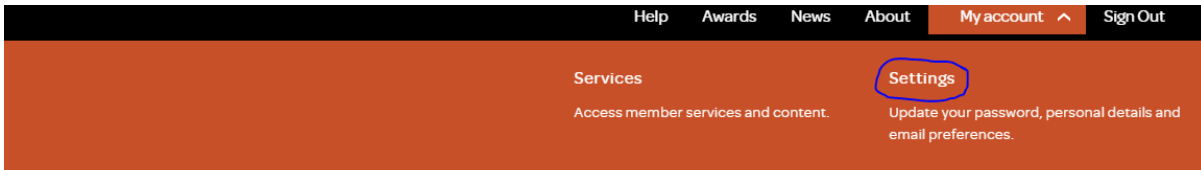
